

## **Mother's Day Bouquet Give-Away – Terms & Conditions**

### **Promotion Name**

Mother's Day Bouquet Give-Away

### **Promoter**

Tasmanian Independent Retailers Co-Operative Society Ltd ("Promoter").

### **Promotional Period**

The Promotion commences at **5:00am AEST on 22 April 2026** and closes at **11:59pm AEST on 3 May 2026** ("Promotional Period").

Entries received outside the Promotional Period will not be accepted. Entries are deemed received at the time they are recorded in the Promoter's database, not at the time of submission by the entrant.

### **Eligibility**

Entry is open to Australian residents aged **18 years or over**.

Employees, directors, officers, contractors and agents of the Promoter, participating stores, and agencies associated with this Promotion, and their immediate family members, are ineligible to enter.

Immediate family member includes spouse, de facto partner, parent, child, sibling, grandparent or step-relative.

Entrants may reside anywhere in Australia, however prize delivery is limited to eligible delivery addresses within Tasmania.

### **How to Enter**

During the Promotional Period, eligible entrants must:

## Judging

All valid entries will be individually judged on:

- Creativity and originality
- Relevance to the theme
- Emotional impact or memorability

Judging will take place at **8:00am AEST on 4 May 2026** at Tasmanian Independent Retailers Co-Operative Society Ltd.

The **100 highest-scoring valid entries**, as determined by the judging panel, will each win a prize.

The judges' decision is final and no correspondence will be entered into.

**One (1) fresh flower bouquet** valued at approximately **AUD \$79.90**, delivered to a nominated recipient within Tasmania.
